

INFORMATION ON DISTRIBUTIONS TO HOLDERS OF ALLOWED CLAIMS AGAINST ADELPHIA COMMUNICATIONS CORPORATION

The following chart summarizes the subsequent distributions to holders of allowed claims against Adelphia Communications Corporation ("ACC") of cash and shares of TWC Class A Common Stock to be made on or about September 8, 2008. Actual distributions may vary due to rounding. The chart is based on the assumption that distributions made to Indenture Trustees for the benefit of the underlying Noteholders were distributed in their entirety to the Noteholders and were not subject to holdback or reduction with respect to any claims of the applicable Indenture Trustee. The chart does not reflect additional distributions that may be made over time as a result of the release of escrows, reserves and holdbacks. The amount and timing of such distributions as a result of the release of escrows, reserves and holdbacks are subject to the terms and conditions of the Plan and numerous other conditions and uncertainties, many of which are outside the control of ACC and its subsidiaries.
