Jane Sullivan, being duly sworn, deposes and says, under the penalty of perjury:

- 1. I am the Executive Director of Financial Balloting Group LLC ("<u>FBG</u>"), located at 757 Third Avenue, New York, New York 10017.
- 2. By (a) Order Approving the Affiliated Debtors' and the Debtors' Agreement With Bankruptcy Services, LLC and Appointing Bankruptcy Services, LLC as Agent of the Court Pursuant to 28 U.S.C. § 156(c), dated June 27, 2002, and (b) Order (I) Approving Disclosure Statement; (II) Fixing Voting Record Date; (III) Approving Solicitation Packages and Procedures for Distribution Thereof; (IV) Approving Forms of Ballots and Establishing Procedures for Voting on Debtors' Fourth Amended Joint Plan of Reorganization; (V) Scheduling Hearing and Establishing Notice and Objection Procedures in Respect of Confirmation of Debtors' Fourth Amended Joint Plan of Reorganization; and (VI) Granting Related Relief, dated November 23, 2005 (the "Initial Solicitation Procedures Order"),

Bankruptcy Services, LLC ("BSI") was appointed to act as, inter alia, solicitation agent to the Debtors¹, for the purposes of soliciting, receiving and tabulating the ballots accepting or rejecting the Plan.

- 3. On April 28, 2006, the United States Bankruptcy Court for the Southern District of New York (the "Court") entered an Order (I) Approving Supplement to Disclosure Statement; (II) Fixing a Record Date; (III) Approving Forms of Ballots; (IV) Establishing Voting Deadlines; and (V) Establishing Objection Procedures in Respect of Confirmation of Debtors' Modified Fourth Amended Joint Plan of Reorganization (the "April 28 Order"). On June 22, 2006, the Court entered an order modifying the Solicitations Procedures Orders (the "Voting Modification Order") that permitted the Debtors to be able to accept, in their discretion, ballots via facsimile and electronic mail.
- 4. On October 17, 2006, the Court entered an Order: (I) Approving Second Supplement to Disclosure Statement; (II) Fixing a Record Date; (III) Approving Forms of Ballots; (IV) Establishing Voting Deadlines; (V) Establishing Objection Procedures in Respect of Confirmation of Fifth Amended Joint Plan of Reorganization of Adelphia Communications Corporation and Certain of its Affiliated Debtors Under Chapter 11 of the Bankruptcy Code; and (VI) Granting Related Relief (the "October 17 Order" and, together with the Initial Solicitation Procedures Order, the April 28 Order, and the Voting Modification Order, the "Solicitation Procedures Orders").

¹ Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Fifth Amended Joint Chapter 11 Plan for Adelphia Communications Corporations and Certain of its Affiliated Debtors, dated October 16, 2006.

- 5. On or about October 20, 2006, FBG was engaged by the Debtors to provide interim reports in connection with the Securities Classes (as defined below), and prepared a letter of agreement in connection therewith. Subsequently, the Debtors expanded the scope of FBG's responsibilities to include tabulation of ballots received in Classes containing votes cast by security holders, including Class ACC 3 (ACC Senior Notes), Class ACC 6 (ACC Subordinated Notes), Class ACC 7 (Existing Securities Law Claims); Class ACC 8 (ACC Preferred Stock Interests), Class ACC 9 (ACC Common Stock Interests), Class SD 6 (Arahova Notes), Class SD 7 (FPL Note Claims), Class SD 8 (Frontiervision Holdco Notes), Class SD 9 (Frontiervision Opco Notes), and Class SD 10 (Olympus Notes) (collectively, the "Securities Classes"), and preparation of the certification to this Court with respect thereto.
- 6. The professionals of FBG have considerable experience in tabulating the ballots of creditors and security holders with respect to plans of reorganization, including Global Crossing, Enron, Loral Space & Communications, NRG Energy, NTL, Owens Corning, Pacific Gas and Electric, Silicon Graphics, and WorldCom.
- 7. As specified in the Solicitation Procedures Orders, the record date for determining the holders of Claims and Interests in the Securities Classes entitled to vote on the Plan was October 18, 2006 (the "Record Date").
- 8. The procedures of BSI for the receipt of ballots are detailed in the Declaration of Angharad Bowdler of Bankruptcy Services LLC With Respect to the Methodology for the Tabulation of and Results of Votes in Certain Classes on the Fifth Amended Joint Chapter 11 Plan for Adelphia Communications Corporation and Certain of its Affiliated Debtors Dated October 16, 2006 (the "BSI Affidavit").

- 9. FBG was instructed to tabulate ballots submitted by holders in the Securities Classes in accordance with the Solicitation Procedures Orders.
- 10. In order for a ballot to be counted as valid, the ballot must have been properly completed in accordance with the Solicitation Procedures Orders and executed by the holder of a Claim, or such holder's authorized representative, and must have been received by BSI by the deadline of 4:00 p.m. (prevailing Eastern Time) November 27, 2006 (the "Voting Deadline"). All ballots included in the tabulation of the Securities Classes were received by the Voting Deadline, except as detailed immediately below.
- 11. In accordance with FBG's customary practice, FBG arranged to pick up master ballots from ADP Investor Communications ("ADP"), which acts as voting agent for a significant number of banks and brokerage firms. FBG's representative was at ADP at the prearranged time of 3:30 p.m. on November 27, 2006. ADP did not provide its master ballots to FBG's representative until approximately 4:30 p.m. In consultation with the Plan proponents, FBG has included the ADP master ballots in the tabulation. The ADP master ballots represent the most significant portion of votes cast in all but one of the Securities Classes, and also contain a significant portion of the votes to reject the Plan in such classes. In my opinion, it would not be justifiable to disenfranchise the large number of beneficial owners that voted through ADP, simply because of a technical misstep on the part of ADP. No other votes in the Securities Classes were received between 4:00 p.m. and 4:30 p.m. on November 27, 2006.
- 12. Ballots not validly executed in accordance with the Solicitation Procedures Orders and/or not received by the Voting Deadline (except as provided herein) were not counted. Issues with respect to the validity of ballots were resolved by FBG's supervisory personnel in

accordance with the Solicitation Procedures Orders, and, in certain cases, in consultation with the

Plan proponents.

In addition to the ADP master ballots, all validly executed ballots cast by creditors 13.

and interest holders in the Securities Classes on or before the Voting Deadline and transmitted by

BSI to FBG for tabulation were tabulated as outlined in the Solicitation Procedures Orders.

14. I hereby certify that the results of the voting by creditors and equity interest

holders in the Securities Classes are as set forth in Exhibit "A" hereto, which is a true and correct

copy of the final tabulation of votes cast by timely and properly completed ballots.

Annexed hereto as Exhibit "B" is a detailed accounting of the properly executed 15.

ballots included in the final tabulation.

A number of ballots were received in the Securities Classes that were not included 16.

in the tabulation. Exhibit "C" to this Certification describes the ballots that FBG did not include

in the tabulation and the reasons the votes reflected on such ballots were not included by FBG in

its vote tabulation.
